Location

The 1998 AP-LS Biennial Conference will be held at the Crowne Plaza Redondo Beach and Marina Hotel 800/368-9760.

Schedule

The conference opens with a plenary session at 12:15 PM on Thursday, March 5 and continues through 4:45 PM on Saturday, March 7.

A pre-conference institute will be held for students on Thursday morning from 9 AM to noon featuring a presentation on current issues in forensic evaluation by Drs. David Shapiro and Jim Ogloff (see p. 4 for details).

The program schedule also includes:

- Saturday luncheon
- Breakfast meeting of the Women in Psychology and Law Committee.

Featured Speakers

Park Dietz, M.D., a forensic psychiatrist and former president of the Academy of Psychiatry and Law will speak on "The Quest for Excellence in Forensic Practice" at the opening session.

Elizabeth Loftus, Ph.D., an eminent cognitive psychologist whose research is devoted to investigations of how memory functions, will deliver an address entitled "Memory and Its Discontents."

Special Session on Repressed Memory

Repressed memories will be the focus of a two hour special session. The session will be organized as an appellate level, admissibility review of repressed memory evidence. An interdisciplinary team, consisting of an attorney and a psychologist will argue for admissibility of repressed memory evidence. They will be opposed by a team arguing against admissibility. Alan Schefflin, a professor of law at Santa Clara University will argue for admitting such testimony. Tim

Reagan, who is currently a Research Associate with the Federal Judicial Center, and last year, as a litigator, successfully argued against the admissibility of repressed memory evidence in the case of Ramona v. Ramona (CA Court of Appeals, 1997) will argue against admissibility.

Additionally, two psychologists will give oral "amicus briefs" as part of each team's 30 minute presentation. The focus will be on the scientific knowledge that exists regarding repressed memories. In light of the conflicting opinions regarding the scientific status of repressed memories, what should a judge/court do?

A panel of three judges including Gerald Rosen, a federal judge from Michigan, will hear the case. The judges will be asked to "think out loud" about their perspectives and offer a judgment whether to admit the proffered evidence. After the judges issue their opinion, there will be an opportunity for the audience to question the judges and the other participants.

More This Year

The meeting in Redondo Beach will have more symposia, paper sessions, and posters than previous biennial conferences. A fourth concurrent paper session was added in an attempt to accommodate the increased demand for opportunities to present.

Lodging

The Crowne Plaza overlooks the Pacific Ocean and King Harbor Marina. Twenty miles of jogging, walking, and biking trails are just outside the hotel and fifteen varied restaurants are within walking distance. The hotel features an outdoor heated pool and sun deck, lighted tennis court, fitness center, and European spa. The hotel is 7 miles from the Los Angeles International Airport and is a short drive to Disneyland, Knott's Berry Farm, Beverly Hills, Universal Studios, and the Fredericks of Hollywood Lingerie Museum.

The Best Western Sunrise Hotel is across the street from the Crowne Plaza. Resource for Attorneys

Sci-Jur possesses a special feature that further enhances its usefulness. Namely, it is an outgrowth of the nationally renowned UNL Law-Psychology Program, directed by Steven Penrod, J.D., Ph.D. This program, which has been in existence for over 20 years (the first of its kind and the largest), is specifically designed to facilitate the ability of legal practitioners to access information and assistance from other disciplines. Considerable research has been conducted on how best to communicate a message to others and to persuade them to accept that message. Sci-Jur staff help attorneys identify and pre-test trial themes and strategies and determine what resources are available and appropriate.

IDENTIFICATION AND RECRUITMENT OF EXPERT WITNESSES and consultants. Attorneys sometimes find locating experts to be a time-consuming chore filled with uncertainty. Sci-Jur's close ties with UNL enable it to readily locate faculty members to fill these roles. In addition, faculty members are sometimes reluctant to become involved when they have not worked with the attorney previously or when they have little experience as an expert. They are often more responsive to an initial contact from Sci-Jur. When desired, Sci-Jur also helps prepare the expert to fill this role. Furthermore, when an expertise is sought that is not available at UNL, Sci-Jur's links enhance its ability to explore academic networks that enable it to find experts at other locations.

CONDUCTING NEW OR ADDITIONAL RESEARCH to serve either as the basis of subsequent expert testimony or as a supplement to experts' existing knowledge on a topic. While an expert may be able to testify regarding his or her general knowledge about an issue, it may be necessary or advisable that the expert incorporate case-specific information or the latest findings in the field into his or her testimony. Sci-Jur professional staff, often times working with UNL faculty members or an attorney expert, design supplemental research to augment an expert insights and direct research teams to conduct this work. This service includes literature reviews to update the expert's knowledge base and research projects generating additional case-specific information.

SUPPLYING TRIAL AND JURY CONSULTATION services, including trial simulations, mock juries, focus groups, jury selection, and the preparation of demonstrative evidence. Interwoven into the services listed above is a need to test and enhance the impact of the strategies and information on the ultimate decision maker, be it a judge, jury, or hearing officer. Sci-Jur conducts trial simulations, mock juries, and focus groups to provide just such a test. These tests, as well as community surveys, are used in turn to guide jury selection and to help in the preparation of demonstrative evidence.

This is the only university-related entity in the country that combines all of these services in one organization. A handful of universities do provide faculty referral services to attorneys and faculty members scattered throughout the country serve as trial and jury consultants.

However, Sci-Jur is the first entity to systematically make available to legal professionals all of the various resources that a university can provide. In addition to the efficiency this approach provides, it may prove particularly useful for attorneys that do not ordinarily have ready access to these types of resources.

Sci-Jur is also unique because it draws upon the extensive faculty, student, and education-related resources of a major research university, and provides the quality services associated with it. Sci-Jur's relationship with UNL also facilitates access to other educational institutions when a resource is sought that is not immediately available at UNL.

These services are very cost-effective and reasonably priced. Sci-Jur, as part of its educational mission, involves students (including post-doctoral, law, graduate, and undergraduate students) in its research teams whenever possible and appropriate. At the same time, all services involving students are designed and supervised either by faculty members or Sci-Jur professional staff, ensuring the quality of the work provided.

The services Sci-Jur provides tend to be case specific, varying with the legal problem or case involved. Just as virtually any subject can be the focus of a legal dispute, the range of assistance that Sci-Jur provides is similarly broad. Attorneys can contact the director of Sci-Jur for a confidential consultation to explore how Sci-Jur might help them.

Jefferson Award for Research

University of Virginia FBI Training Academy

Each year since 1981, the University of Virginia has offered the Jefferson Award for Research at the FBI Academy. The award was developed to encourage and recognize academic research efforts of the FBI faculty. The award promotes the generation of new knowledge and fosters the development of insight into disciplines related to criminal justice. To be eligible for the award, the nominated works must show a high level of creativity, must have potential for improvement of the criminal justice system, and must involve a scholarly process. The award consists of a medallion and citation and is presented at the annual awards meeting held in the Rotunda of the University of Virginia.

This year's Jefferson Award recipient is Dr. Anthony J. Pinizzotto, of the FBI's Behavioral Science Unit in Quantico, VA. His research with Mr. Edward F. Davis and Mr. Charles E. Miller on assaults on law enforcement officers, In the Line of Fire, is scheduled for release in January of 1998. This report is the second of a series of studies examining issues of law enforcement officer safety. The first report, Killed in the Line of Duty, was published in September of 1992.

Dr. Pinizzotto received a Ph.D. in psychology from Georgetown University in 1988, a bachelor's degree in English from Allentown College of St. Francis de Sales in 1974, an M.A. in 1982 in forensic psychology from John Jay College of Criminal Justice, and an M.A. in theology in 1978 from DeSales School of Theology in Washington D.C. He currently holds the position of forensic psychologist at the FBI's Behavioral Science Unit in Quantico, VA. Dr. Pinizzotto is a member of APA and AP-L.S. ■

A consultant or expert who is working with an attorney can similarly contact Sci-Jur to ascertain whether there is any research or information that Sci-Jur can provide to better prepare this consultant or expert to fulfill his or her role. Consultants sometimes do not have sufficient resources of their own to meet the needs of a potential client. For example, an individual may be asked to serve as an expert witness, but need assistance generating supplemental research. Sci-Jur assembles resources (e.g., a faculty-led student research team) to also assist consultants.

We are all very excited at the prospects of the conference and hope to see everyone there. Remember that you don't have to be presenting to attend. In fact, the conference promises to be a great time of both social and intellectual interaction with fellow students and professionals.

AP-LS Student Workshop

We would like to take a minute to highlight one key event we have been coordinating for the conference, namely the AP-LS Student Workshop. This special event is targeted toward students in the organization, with the purpose of enhancing their educational experience through the analysis and discussion of timely topics by various experts in the field. This year, we have chosen to focus upon the process and controversies of forensic evaluation. The workshop will take place from 9 a.m. to Noon on the first day of the conference, Thursday, March 5th. Presenters include, among others, Dr. Jim Ogloff and Dr. David Shapiro. Preliminary plans for the workshop involve the discussion of several hypothetical forensic cases, in addition to critiques of various interview techniques and tests. The stages of a forensic evaluation will also be reviewed, including important ethical issues that arise along the way. The workshop is designed to be a hands-on and interactive experience to which all students are invited.

Budget-Trimming Tips

We know that, if you are like most of us "students," limited funds may greatly influence your decision to attend the conference. However,

there are many ways a trip such as this may be manageable on a limited budget. Here, we would like to provide several money-saving tips on getting to the conference with limited funding:

1. Start your planning EARLY. It really is true that the "early bird gets the worm," or, in this case, the best chances at obtaining funding and the most competitive travel rates.
2. Inquire at both the departmental and university levels about travel awards or small grants for which you might apply. Most universities have these available; however stipulations may complicate the process, so be prepared for some delays. In addition, many conferences provide special rates, travel awards, or presentation incentives for students. For example, all student presenters (first authors) at the Biennial Conference this March will receive registration fee waivers.
3. Book your flight early, and shop around for the best deals. Most travel agencies will quote similar prices, although they often change on a day-to-day basis. Even though it is sometimes difficult to do so, booking a flight at least 3-4 months in advance can save you hundreds of dollars in costly airfare.
4. Connect with others in your department or university who are also planning to attend the conference. Often you will be able to save hundreds of dollars by sharing a hotel room with several others. Remember that you don't have to stay at the conference hotel. Generally speaking, most areas have 2 or 3 lesser priced hotels within walking distance of the conference center. For example, there is a Best Western hotel located across the street from the conference hotel in Redondo

Beach that is advertising very affordable rates.

5. Lastly, establish a budget for spending on food, entertainment, and other miscellaneous costs you are likely to encounter. Inquire from others who have been to that particular city regarding the restaurant atmosphere and various cultural/entertainment events in the area. This will allow you to be realistic in your planning.

In closing, the AP-LS Student Section Council would like to extend its very best wishes for a prosperous new year. We are looking forward to growing more attune with your needs and ideas for the direction of this organization. As such, we would love to hear from you, so please don't hesitate to drop us a line.

Mental Health Law, Policy, and Forensic Psychology
